

#### DRESS LIKE



Each year the Kiwanis Club of Kankakee hosts the Shoe Project where students in need from local schools are brought to shop for a pair of shoes. This year, with the help of a grant from the Community Stewardship Fund at the Community Foundation, over 200 kids were connected with new shoes and socks for the winter season!

Partnered with the local Kohls and Shoe Carnival, volunteers helped students find the perfect fit.









In November of 2020, the Foundation announced the matching funds challenge for the Fine Arts Fund put forth by former executive director Norm Strasma in memory of his wife, Janice, who passed in 2018. Mr. Strasma generously chose to match donations up to \$50,000. This will allow the fund to grant up to \$5,000 each year to support programs in the areas of literature, music, architecture, sculpture, painting, performing arts, and film.

The Christmas with the Arts event was held last December as an interactive fundraiser incorporating all areas of the Arts. The fund is now over \$62,000, including matching funds earned so far, bringing us over halfway to our goal. With this achievement, the Foundation plans to launch the Fine Arts grant cycle this fall.

# LIVE LIKE P+H-0-E-B-E

Pledge for Life Partnership (PfL) has been a pioneer in promoting the health and well-being of children and their families by utilizing the Life Education Center programs to promote healthy lifestyles throughout schools in Kankakee and Iroquois Counties.

PfL project "Keep Moving Forward: Body + Mind + Heart" enables their organization to enrich prevention education efforts with students to improve their physical and mental health by participating in mini-lessons which builds skills to learn how to balance screen time, deal with conflict, healthy friendships, handle emotions, think positive and persevere. This project positively impacted approximately 5,000 kindergarteners through 3rd grade students in 31 different schools throughout the counties.







Grant funding from the Robert K. Dunn fund supported Northern Illinois Food Bank with their Summer Family Markets in Kankakee County. This program provides a selection of fresh food, including protein, dairy and produce, shelf stable groceries and sometimes household supplies. Summer Family Markets are planned in coordination with local organizations with connections to families who are facing increased hunger risk during the summer school break.

In 2021, Northern IL Food bank partnered with Bradley Public Library and Pembroke Fellowship Church to reach local families and provided space for the Food Bank's Mobile Pantry truck to park and distribute food to families in need.

# CHANDLER

Bradley-Bourbonnais Community High School's Robotics Team, Team Ironclad, began in April 2014. BBCHS Ironclad has been a recipient of the Communityworks grant, assisting students in the area of workforce development, for the past several years. The intended purpose of this program is to advance high school students' skill sets in science, technology, engineering, and math as well as art (STEAM).

Mentors volunteer their time and talents to guide the students during the build season for evenings and weekends of side-by--side work. Last year 45 students participated on the Ironclad Robotics team, taking home three 2nd place wins in their competition season.







Since 2018, LoveALatte has traveled Kankakee County to bring their pop-up coffee shop to events. Their organization provides job training opportunities for individuals with disabilities in Kankakee County. Their interns receive hands on training in customer service, money management, food and beverage preparation, and soft skills. After a successful internship with their organization, LoveALatte assists them with finding long-term employment and provides a letter of recommendation based on individual strengths. Over the years, the Communityworks grant has helped them grow from a small tent to a mobile trailer dedicated to their shop.

As their nonprofit has grown, they have worked to provide an authentic coffee shop environment for their interns and customers. With the 2021 Communityworks grant, LoveALatte purchased a commercial espresso machine and commercial grade blender for their coffee shop. This has allowed them to teach their interns how to make lattes that are similar to those served at popular coffee shop chains and expand their menu.



Even throughout 2021 our communities were dealing with the aftereffects of the COVID-19 pandemic. While most of the world was still at a halt, nonprofits in our communities worked diligently to meet the needs of our communities. The Community Response Fund continued awarding COVID-19 Community Response Grants throughout the year to assist nonprofit organizations with serving community members in need.

The Fund awarded \$79,789 throughout 6 different organizations enabling access to emergency food and basic supplies; interim housing and shelter; primary health care services; utility and financial assistance; nonprofit safety and operations assistance; and supports for children and other populations vulnerable to COVID-19.

## THE ONE WHERE THEY PIVOT



## PROJECT S. V. N

#### **Project SUN Launches First Phase of Equity Initiative**

Addressing equity is paramount to establishing a children's mental health system of care that meets the needs of all youth and their families. Project SUN strives to take into account different languages, cultures, races, genders, and economic situations,

as well as different needs in the urban, rural, and suburban areas of the county. For these reasons, during 2021, Project SUN launched an initiative to understand our different experiences and promote action towards equity and access to children's mental health services in Kankakee County.

The first phase of this undertaking is a multi-level approach to better understand the different experiences Black/African American, Hispanic/Latinx, and White members of the community have had regarding racial discrimination. Future undertakings will address the needs of other marginalized groups, including members of the LGBTQ+community.

The initial activity was to conduct a Racial Equity Assessment Community Survey by recruiting participants at several events during the summer months and through Project SUN communication channels. Over 250 Kankakee County residents responded. This provided much rich data for Olivet Nazarene Senior Social Work students to analyze. In addition to looking at the survey results, the students also researched strategies that have been successful in eliminating structural racism in other communities. In December, they presented their results to representatives of Project SUN's Executive and Community Planning Teams.



The next component was to host the first round of "My Piece in the Puzzle," a four-session program intended to prepare individuals to engage in difficult conversations related to race. Approximately 30 individuals participated in these sessions preparing them to take next steps to promote healthy dialogue. Those interested in continuing to work with Project SUN will have the opportunity to be trained as Racial Healing Ambassadors who will facilitate additional discussions throughout the community based on the "My Piece in the Puzzle" model.
